## Looking back at the year 2025

### Floods are top story, Myrtle Creek resignations check in second

The year of 2025 saw several oddities throughout the region and flooding was one that has not been seen since the 1990s.

The City of Myrtle Creek also saw changes ranging from the resignation of first, then Mayor Matthew Hald to City Administrator Lonnie Rainville to the on boarding of two new city councilors in the form of Rick Held and Kathey Wragg.

What follows are these top stories in their entirety as they were covered by The Douglas County Mail.

That is followed by a chronological look at the year.

There will also be a myriad of pictures included.

#### MARCH 20

#### South Douglas County reeling from storm

MYRTLE CREEK – The rains that hit the Pacific Northwest and California, and more specifically Douglas County, this last weekend wreaked havoc throughout the region with flooding occurring all over the county and state.

The rains began falling late last week with as much as over  $\frac{3}{4}$  an inch on Thursday and a quarter-inch on Friday but they really began to intensify late Saturday evening and into the night as over an inch fell.

Sunday morning saw torrential downpours mixed with blizzard-like conditions and all waterways beginning to swell as almost 2 inches of precipitation fell on the area.

Myrtle Creek was still within its banks at around noon but by 2:30 it was flowing into the Ireland lot on South Main Street and into the businesses. The residents on Mill Street and Pete's Street were given evacuation notices along with some residents on Broadway, Oak, Spruce, Maple, Howland, Short and others on Sunday afternoon as the water rose and filled Evergreen Park, Creekside Memorial Park, portions of Millsite Park, the RV Park and the Disc Golf Course.

According to reports, at one point the water level was about a foot below the drive-thru window at Justice's Java.

Myrtle Creek was not the only area impacted by the storm. Riddle saw Cow Creek overflowing its banks along Yocum Road and up to the city water treatment plant.

The walking path behind the high school was under water.

Over Canyonville – Riddle Road there was at one point as much as two inches of snow which created some hazardous driving conditions.

In Canyonville the storm drains could not handle the intensity of the run off and several businesses along Main Street were flooding.

The small creek running through Pioneer Park was just about to overflow its banks at 2 p.m. Sunday afternoon.

The Douglas County Commiss-

sioners did declare a State of Emergency on Sunday. The Douglas County Commissioners and Douglas County Emergency Management Department have teamed up with the Oregon Department of Emergency Management (OEM) to provide resource and information to local residents via the 211 Info Line. 211info is a free phone line that assists Oregon and Southwest Washington communities by helping people identify, navigate, and connect with the local resources they need. If you have questions about insurance, flood damage, resources, or housing call 211. If you have a non-emergent need for assistance, call the non-emergency line with the Douglas County 911 Communications Dispatch Center at (541) 440-4471. If you have a life-threatening situation, please call 911.

These flood waters are the highest seen in the area since 1996 when Millsite and the aforementioned areas were flooded. That year there were three separate, but linked incidents that saw flooding occur within the area. November 18-19, December 4-9 and January 1-2, 1997. There is more rain predicted for this week.

#### MARCH 27

#### State, county, city declare State of Emergency due to storms

MYRTLE CREEK – The State of Oregon, Douglas County and the City of Myrtle Creek have all declared a state of emergency due to the flooding and landslides that have occurred throughout the area since February 24 through March 18.

The Douglas County commissioners were the first to make the declaration on March 16.

The Douglas County Board of Commissioners Declared a State of Emergency on Sunday, March 16, 2025, at 10:15 a.m. for the entire county due to the "extreme conditions related to the severe winter storm that impacted our county causing extreme peril to the safety or person and/or the protection of property." A declaration of emergency empowers authorities to take extraordinary measures to protect lives, property, and public health, including accessing emergency funds, and coordinating resources for rapid response and recovery.

Although floodwaters have receded in some parts of the county, many areas are still experiencing the impact of flooding, including high water, road closures, detours, mudslides, debris, downed trees, falling rocks, and damaged roadways. Please be aware that some areas may continue to experience elevated water levels for an undetermined amount of time.

etermined period of time and there is an increased risk of mudslides and falling rocks in areas with steep terrain.

On March 18, Governor Tina Kotek declared a state of emergency due to flooding and landslides from February 24 through March 18, 2025. "When emergencies hit, Oregon families and businesses need to know we have their back in every part of the state," Governor Kotek said. "Recovery starts as soon as disaster strikes, and this declaration will help get Oregonians back to normal as soon as possible. I urge everyone to follow the instructions and evacuation levels issued by emergency officials, subscribe to emergency alerts on ORAlert.gov, have an evacuation plan, prepare a go-kit, and stay aware of changing conditions." Following ORS 401.165, the Governor determined a potential threat to life, safety, property, and significant damage to infrastructure exists due to flooding and landslides that have caused and continue to cause a state of emergency in Clackamas, Coos, Curry, Douglas, Harney, Jackson, Josephine, Lane, Multnomah, and Malheur counties. At the time of this release, the Governor's Office is closely monitoring a potential flood in the Burns area of Harney County and preemptively added Harney County to this declaration. Beginning on February 24, 2025, ongoing storms have caused significant flooding and landslides throughout Oregon, resulting in one fatality, critical transportation failures and loss of power and communications capabilities. This declaration directs the Oregon Department of Transportation to provide appropriate assistance and seek federal resources to repair and reconstruct the \$10 million dollars or more in damages and impact to the federal aid highway system in the impacted counties. This declaration is limited to the provision of assistance by the Oregon Department of Transportation to repair and reconstruct eligible roadways that are part of the federal aid highway system. This declaration is not to be construed as a comprehensive declaration or proclamation of emergency for other purposes. On March 17, the Oregon Department of Emergency Management (OEM) activated the State Emergency Coordination Center (ECC) to Level 3, which means the state is coordinating closely with local, Tribal, and state partners to share information and support local response and recovery operations as needed. MYRTLE CREEK -- The wine was flowing freely leading up to the handing out of the roses to Shane Kelly and Joanna Bilbrey as they were named Man and Woman of the Year, respectively, at the 67th Annual Myrtle Creek-Tri City Area Chamber of Commerce's Citizen of the Year Banquet.

The event, held Saturday night at the Richwine Vineyards, also saw Barbara Sutch, longtime volunteer at St. Vincent de Paul's Food Pantry, was honored with the Lifetime Achievement Award.

President Susan Harris formally opened the evening's proceedings.

She spoke about how last year was a pretty good year for businesses in the area.

Harris spoke about a lot of new things that were already going on in Myrtle Creek this year with the Imagine Myrtle Creek program.

"This is a community driven revitalization effort aimed at developing a long-term vision and strategic success plan for the city," said Harris

The first awards of the evening were of a solemn note, those being inductions into the Legacy Circle.

The Legacy Circle was established by the chamber board in 2003, representing a continuum that can never be broken. It honors business and civic leaders who have passed away within the last year.

Those inducted this year were Dean Bloemendaal, Ken Brouillard and Roland Theiss.

Bloemendaal was a 36 year member of the Myrtle Creek Elks Lodge. He was a Past Exalted Ruler and Past District Deputy Grand Exalted Ruler Auditor. During his many years as a member he made significant contributions to the the lodge the the local communities. Many people remember him for his storytelling.

He worked as an accountant and a tax preparer most of his life and early on was employed by CBS.

He loved to talk about his time rubbing elbows with the stars and having been kissed by Lucille Ball.

Brouillard came to Myrtle Creek in 1989 to be the new Postmaster. He started working for the postal service in 1965. After moving to Myrtle Creek he served as Postmaster until retirement in 2001.

Brouillard served on city council twice and also as Mayor of Myrtle Creek for four years. He was also on the planning commission and the budget committee. He also spent 10 years volunteering with the Douglas County

Sheriff's Office Search and Rescue. He loved to four wheel, especially in his Rubiken Jeep and was the driving force behind the creation of the Rock Crawl. He and his wife, Marilyn, were awarded the Chamber's Lifetime Achievement Award in 2019.

Theiss started out working in the logging industry but eventually transitioned to other areas. He purchased two gas stations in the area, one in Myrtle Creek and one in Winston and operated them for several years. He then transitioned into real estate becoming a broker for Village Realty, which he later purchased and continued to operate until his retirement.

He also built, owned and operated storage units in Myrtle Creek, Canyonville and Riddle up until selling the businesses in the early 2000 teens.

He was a 59 year member of the Myrtle Creek Elks and was also co-founder, chairman and co-chair of the South Douglas Rodeo. He loved white water rafting and was most at home on the Rogue River. Over the years he came to be known as Roland on the River.

He was named the Chamber's Man of the Year in 2006.

Trevor and Jessica Sharon of The Regal Raptor presented the Business of the Year award, having received the award in 2024.

"We couldn't be more excited to pass along the title of Business of the Year to a much deserving new business in Myrtle Creek,

**Kids take to the skies of Myrtle Creek**

MYRTLE CREEK – Saturday morning, April 12, the skies around Myrtle Creek were alive with the sounds of small prop planes flying all over the place.

The reason for the "invasion" was the National Experimental Aircraft Association local Chapter 495 of Roseburg was holding a Young Eagles event at the Myrtle Creek

Airport.

The Young Eagles program is an aviation/educational program that provides multiple opportunities for students interested in aviation as a possible hobby or career. They register kids aged 8-17 for a free airplane ride.

According to Young Eagles Coordinator Ken Nichols, they have been hosting these events in Roseburg where we have flown over 250 kids in the last two years.

Nichols, who likes to fly down the Myrtle Creek during the fly-in breakfast events or the fly-in BBQ, said back in February when it was cold, calm and clear he flew down to the Myrtle Creek airport and talked with Bruce Harlow who is caretaker of the field. They talked about the Young Eagles and the possibility of hosting an event here and it quickly became a possibility and with the blessing from the city and help from Bruce and Kevin Weaver from the South Umpqua School District they scheduled this event and possibly will hold another one here this year.

They were hoping to field four aircraft with a colorful bi-plane, a vintage 1947 Er-coupe plus a Experimental home built Glasstar as well as a Oregon produced kit a Vans RV-6 but got lucky and had five show up which included Douglas County Commissioner Chris Boice with his 205 Cessna. Boice had flown over 50 missions for this program.

Nichols said their hope was to host around 30 kids for the day. All kids being from the Myrtle Creek Tri-City area.

MYRTLE CREEK – On March 28 at approximately 7:54 a.m., an officer from the Myrtle Creek Police Department was dispatched to the skate park/swimming pool area at 200 Rice Street for a report of criminal mischief. When the officer arrived, he discovered the skate park area was heavily spray painted with vulgar words.

While the officer was on scene, he also discovered two custom made picnic benches had been tipped over causing the seats to be broken.

During the officer's investigation, the officer learned areas at Millsite Park had also been spray painted.

The officer continued to investigate the incident and developed leads that several juveniles and one adult were responsible for the damage. The officer also discovered during his investigation that three of the juveniles on the same day had gone into a local store and stole several bottles of alcoholic beverages and other items.

On March 29 the officer made contact with the four juveniles ages 14 to 17. After the officer conducted interviews, the juveniles were ultimately cited and released to their parents for criminal mischief in the second degree. Three of the juveniles were also cited for theft in the third degree.

On April 15 the officer was finally able to make contact with 20-year-old Katherine Doolittle of Canyonville who was a suspect.

After the officer interviewed Doolittle, she was taken into custody and lodged at the Douglas County Jail for criminal mischief in the second degree.

## MAY 15

### Riddle man busted for making, dealing fentanyl

GLENDALE – Thursday afternoon, May 8, detectives with the Douglas Interagency Narcotics Team (DINT) arrested a Riddle man, Bobby Hogue, on several fentanyl related charges.

At approximately 4:15 p.m. detectives, with assistance from the Douglas County Sheriff's Office, initiated a traffic stop on a vehicle traveling northbound on I-5 near milepost 83, which is in the Glendale area. A search of the vehicle revealed approximately 115 grams of suspected fentanyl, along with a small amount of suspected methamphetamine. Hogue, 34, of Riddle, was detained at the scene.

A short time later, a search of Hogue's residence in the 3,000 block of Canyonville-Riddle Road revealed a small amount of suspected methamphetamine as well as a firearm. Previously convicted felons are prohibited from possessing firearms.

Hogue was arrested and lodged at the Douglas County Jail on suspicion of Possession, Delivery, and Manufacture of a Schedule II Controlled Substance, and Felon in Possession of a Firearm.

The Douglas Interagency Narcotics Team (DINT) is a multi-jurisdictional narcotics task force that identifies, disrupts, and dismantles local, multi-state, and international drug trafficking organizations using an intelligence-driven, multi-agency prosecutor-supported approach. DINT is supported by the Oregon-Idaho High-Intensity Drug Trafficking Area (HIDTA) and is composed of members from the Douglas County Sheriff's Office, Roseburg Police Department, Oregon State Police, Douglas County District Attorney's Office, and the Bureau of Land Management.

The Oregon-Idaho HIDTA program is an Office of National Drug Control Policy (ONDCP) sponsored counterdrug grant program that coordinates with and provides funding resources to multi-agency drug enforcement initiatives, including DINT.

This year there was also a Kids Activity Center sponsored by Riddle Roots and other family activities including axe throwing, a mechanical bull, a climbing wall and live camel rides. 
to Graduate Program, \$140; high school band program, \$140; high school positive behavior support program, \$140; and the high school world and cultural art program, \$140.

Kids First serves children for concerns of sexual or physical abuse as well as children who have witnessed a violent crime.


Klamath Advocacy offers safe spaces and inclusive services to people who have experienced trafficking.





## JULY 17

## Myrtle Creek man arrested on sundry of weapons charges

MYRTLE CREEK -- On July 7 at approximately 7:25 a.m. Myrtle Creek Police Department Officers responded to the 700 block of Cedar Avenue for a report regarding damage found on a residence from gun shots. The person making the report believed his neighbor from 726 Cedar Avenue had shot his residence with a firearm sometime during the night. Officers arrived on scene and found evidence that someone had shot the residence at least twice with a shotgun or a firearm that shoots shotgun pellets.

While officers were on scene investigating, Jay Wilson, who lives at 726 Cedar Avenue, began yelling at officers from inside his res-

idence. Officers had prior knowledge that Wilson was possibly heavily armed, and his behavior has recently become more erratic.

Officers began setting up a perimeter while a search warrant was being written for Wilson's residence. During that time, Myrtle Creek Police Department contacted the Douglas County Sheriff's Office and requested they have their Tactical Response Team (TRT) respond to execute the warrant, due to the high risk.

The Myrtle Creek Police Department also requested Douglas County Communications alert residents in the surrounding area to shelter in place and avoid the area.

While Officers were waiting for the search warrant, Wilson fired at least two rounds from inside his residence. No one was hit and no officers returned fire.

Crisis negotiators from the Douglas County Sheriff's Office began trying to communicate with Wilson, but Wilson continued to remain agitated.

At approximately 10:07 a.m. Wilson exited his residence and began walking down the street. Officers rushed in and were able to take Wilson into custody without any further incident.

Wilson was transported to the Douglas County Jail where he was lodged on 21 counts of unlawful use of a weapon, 21 counts of recklessly endangering another person, and two counts of criminal mischief in the second degree.

Later in the evening, a search warrant was executed on Wilson's residence where 67 firearms were seized along with large amounts of ammunition.

During the search warrant, officers found evidence of Wilson firing several rounds from a shotgun and handgun through his front door, windows, and the wall towards his neighbor's house.

The Douglas County Sheriff's Office, Winston Police Department, and Oregon State Police assisted with the incident.

## JULY 24

## Myrtle Creek is one of the chosen

MYRTLE CREEK -- The City of Myrtle Creek became one of 50 last week and more specifically number 24, as artist Cheyenne Renee selected the city for her mural project.

Renee, a young artist from Covington, Virginia, has a goal to paint 50 murals, one in a small town in each state before the end of 2025, thus the name of her project 50 in 50.

The way that Myrtle Creek got involved in the project was due to McKenzie Strong. Strong, one of the new owners of Homestead Furniture, found Renee's project online and submitted an application to the project.

According to Renee, one of the things that intrigued her the most about the Myrtle Creek application was that the city recently announced that it was establishing a mural committee to solicit and encourage artists to come paint murals in Myrtle Creek.

Once she accepted the application Strong quickly began to look for a wall to use for the mural. That's when she made contact with Byron Magillo who recently purchased the old Rose Motel.

It just so happened that the wall facing Main Street was blank and he was more than willing to be a part of the project.

"It was refreshing and exciting to find a small town willing to move forward and be very progressive in an effort to encourage tourism," said Renee.

The project started in April of 2022 in her hometown and has since reached 24. Renee says that she has all but eight states booked.

She has accepted applications from towns ranging in size from 200 to 60,000 residents.

It doesn't take her long to complete the task either.

She rolled into town on Friday, July 11, stated work on the mural on Monday, July 14, and completed the project on Thursday, July 17, and was on her way to her next project in Washington Thursday night.

In addition to the murals she is also putting together a documentary that highlights each community and the people that are doing amazing things for those around them.

She had the opportunity to interview a local Myrtle Creek icon, Dora Dyer, during her time here.


Her goal with the documentary is to provide a copy or access to it when completed and have each community do a viewing party as part of the unveiling of the video.

Queen's Court  
returns to Pioneer  
Days along with  
other favorites

CANYONVILLE -- The South Umpqua Historical Society along with the Canyonville Pioneer Days Committee decided to bring back the Queen's Court feature to the annual celebration.

This features highlights princesses from the surrounding communities to include Myrtle Creek, Days Creek, Riddle, Azalea/Glendale and Canyonville and brings them together on Thursday evening for the coronation of this year's Queen.

That distinction is determined by lot and announced that evening. The princesses and the queen will also be riding in the parade on Saturday.

Another favorite of yester-year making its return is the Canyonville Lions barbecue dinner on Thursday evening at 5:30 p.m.

This was a sought after favorite for many years but has been on hiatus for the last several years.

This year's menu includes ribs, chicken, baked beans, coleslaw, watermelon and either water or lemonade all for just \$20 per person and only \$15 for senior and children under 12. All proceeds from the event will go to the local sight and hearing which helps to provide glasses and hearing aids for those who can't afford them. So be sure to get out for the dinner and the coronation.

Commissioner Freeman began the discussion by correcting misinformation regarding the formation of the independent transportation district. In 2017, the Board of Commissioners was ap-

roached by representatives from several local agencies, along with community members, who advocated for the creation of a separate transportation district in Douglas County. They believed that establishing an independent district, separate from county government, would better serve the community's interests. One key reason cited was the expectation that a stand-alone district would have greater leverage in securing additional grant funding. On August 15, 2018, the Douglas County Board of Commissioners held the first public hearing and signed an order initiating the formation of an independent Douglas County Transportation District. A follow-up public hearing was held on September 12, 2018, to consider finalizing the district's creation. After hearing public testimony, the Commissioners unanimously approved an order officially establishing the district, with boundaries generally aligned with those of Douglas County.

The newly formed Douglas County Transportation District was established as an independent, non-taxing entity, meaning it would not collect local tax dollars. Instead, funding would be allocated directly to the district and would not come through the county.

Governance of the district was assigned to an elected board, responsible for managing and overseeing the use of millions in funding. The next step in the process was the election of the board of directors. In November 2018, Douglas County voters elected seven board members from a field of 16 candidates. Following the election, the legal transition of the transportation program began, with all actions carried out in accordance with state statutes to formally transfer operations to the newly independent district.

The final responsibility of Douglas County Government in this process was to oversee the initial board meeting in January 2019, during which board positions and term lengths were determined. Since that time, the district, now known as the Umpqua Public Transportation District, has operated independently of county government.

To help set the record straight and address the misinformation being circulated, the Douglas County Board of Commissioners issued the following key points

The Douglas County Board of Commissioners were NOT involved in the last election of officers for UPTD.

# Looking back at sports in 2025

## Lady Lancers softball, Days Creek boys basketball, Riddle football, Lancer boys soccer top list

MYRTLE CREEK -- The year of 2025 in sport marked accomplishments for several teams that had not been done in a number of years.

The South Umpqua Lady Lancers softball team made another deep run into the semifinals before falling.

The Riddle football team made the playoffs for the first time in nearly 30 years.

The South Umpqua boys soccer team made a run to the playoffs that included an undefeated divisional season and only two losses on the year with one coming in the second round of the playoffs.

The Days Creek boys basketball team led off the year with a run to the Elite Eight in Baker City.

What follows are these stories as they were covered followed by a chronological look at the year in sports.

### MAY 1

#### Lady Lancers rounding into form

TRI CITY -- The South Umpqua softball team is starting to take on some resemblance to last year's championship team as they continued to roll through the Far West League remaining undefeated in league play and in a tie for first place with both Douglas and Glide at 6-0.

South Umpqua last week completed a three game home-and-home sweep of Sutherlin.

On Tuesday the Lancers beat the Lady Bulldogs 16-0 in a three-inning, Mercy Rule shortened game. Mady Pratt went 3-for-3 with three RBIs while Haley Twyman was 2-for-2 with one RBI. Danika Richardson chipped in going 2-for-3 with three RBIs.

Reagan Gilbert was on the hill and got the victory.

On Friday the Lancers traveled to Sutherlin for a double dip which they took 15-0 in three innings and 19-2 in five innings.

In the first contest Tessa Beam had a good game going

**RIDDLE** — The Riddle Irish football squad got off to a slow start and things didn't look so good after the first quarter but the Irish kept plugging away and eventually ran over the visiting Yoncalla Eagles in a 40-24 season opening victory.

The running attack of the Irish took a while to get going but behind the legs of Isaiah Ibrahim who ran for 281 yards and four touchdowns, Riddle netted over 400 yards on the ground.



Roland Johnnie Theiss, 86, of Myrtle Creek died January 3 surrounded by his three children, Anthony Wade Theiss, Tonya Ann Theiss Skrip, and Roland Todd Theiss, as well as other close family members.

Born in Dallas, Oregon, October 10, 1938, to John and Marelyn Theiss,

He lived a full life and was an inspiring leader to his family and many citizens of Douglas County and beyond. After schooling, Roland met the love of his life, Margaret 'Margie' Sherman from Ten-mile, Oregon. After a classic and joyous courtship, they wed on November 1, 1958, and remained married until her death in 2019.

Simultaneously, he worked in the logging industry for several years for his father and uncles and later joined other local operators such as M & B Logging, Teco, and Conifer Douglas.

He started his entrepreneurial journey as his family grew by purchasing and operating two service stations, the Union 76 in Myrtle Creek and the Shell Station in Winston. With his wife as a full-time mother of eventually three, he transitioned into the real estate industry and became a broker with Village Realty in Myrtle Creek. He helped many people with dreams of home ownership buy their first home with his experience and creativity, always finding solutions for his clients. During his over 40 years in the business, many people approached him with a warm embrace to tell him that he was the person who helped them buy the homes in which they raised their families and helped secure their dreams and their futures.

She first met her husband, Gordon McAhren on St. Patrick's Day 1972 and it was love at first sight.


The couple enjoyed traveling and created many wonderful memories.





**Myrtle Creek man arrested on drug charges**

MYRTLE CREEK – Myrtle Creek resident Chet Evans was arrested last week on drug charges.

On Wednesday, November 6, detectives with the Douglas Interagency Narcotics Team (DINT) witnessed possible drug activity within the intersection of NE Casper Ave and NE Odell Ave in Roseburg. At approximately 9:45 a.m., with assistance from the Douglas County Sheriff's Office, detectives contacted Evans, 38, of Myrtle Creek.

Evans was detained and a search of him and his vehicle revealed approximately 3.5 grams of suspected fentanyl and a glass pipe with suspected methamphetamine residue. Evans was also in possession of brass knuckles and an expandable baton. Evans is currently on Felony Probation and has multiple felony convictions.

Evans was lodged at the Douglas County Jail on two counts of Felon in Possession of a Restricted Weapon, Unlawful Possession of a Schedule II Controlled Substance, Unlawful Possession of Methamphetamine and is on a Probation Detainer for Lane County.

Twete was arrested and taken to the Douglas County Jail and charged with Driving While Suspended or Revoked and three counts each of Unlawful Manufacture of Methamphetamine, Unlawful Delivery of Methamphetamine and Unlawful Possession of Methamphetamine.

ball.

It started about a minute into the quarter when the Pelicans scored on a 35 yard pitch and catch. However they still couldn't convert on the extra points and trailed 12-25.

The Lancer offense went cold and once again the defense had their backs to the wall as Klamath Union drove down the field and put it in the end zone with 5:09 left.

Another missed opportunity on the conversion saw the Lancer lead remain at seven, 25-18. The Pelicans' defense held the Lancers and got the ball back and drove it down into Lancer territory. The SU defense stiffened and stopped them on four successive plays to take over on downs and ran the clock out.
